This letter is to notify you that your child is eligible to attend Academic Summer School on June 14 and June 15. Academic Summer School is designed for students who passed the course but did not score at the "proficient" level (scored Level 1 or Level 2) on their End of Course Biology and/or Math 1 tests this school year. Your child will be afforded an opportunity to remediate and retake the NC EOC test(s) for Biology and/or Math 1. This is a wonderful opportunity for our students to improve their proficiency rating. Academic Summer School is free of charge and students must attend both days (June 14 and 15) to be eligible for this opportunity.

<u>Biology</u>: Location for Academic Summer School for Biology will be at Pisgah High School in Room _____. Remediation/review for Biology will be on June 14 from 8:30 to 11:30 and retest for Biology will be June 15 from 12:30 to 3:30.

Math 1: Location for Academic Summer School for Math 1 will be at Pisgah High School in Room _____. Remediation/review for Math 1 will be on June 14 from 12:30 to 3:30 and retest for Math 1 will be June 15 from 8:30 to 11:30.

Because of the short notification period, you may be contacted, by phone or other means, to inform you if it would be advantageous for your child to attend Academic Summer School on June 14 and 15. This letter is to notify you that your child is recommended to attend Credit Recovery/Summer School and currently registered for the program per my phone conversation and/or in-person meeting with you and your child.

2017-2018 Summer School Guidelines

- Free of charge
- All course offerings in summer school will be for credit recovery only. The courses will be online with supervision at Pisgah High School.
- The summer school session is June 18-June 21. Students will be required to attend daily or until the course is satisfactorily completed.
- Credit recovery for EOC courses is available ONLY if the student achieves a passing score of Level III or above on the state EOC tests. This includes Math I, English II and Biology.
- For other courses, students must have passed the NC Final Exam to be eligible to attend summer school for credit recovery.
- All courses must be completed by June 21st at 4:00 p.m.
- Absences may not exceed two days. Two tardies count as one absence. Arriving after 8:00 is a tardy.
- Students will be dismissed from summer school for misconduct.
- Upon successful completion of summer school, a Pass will be entered on the transcript.

Please sign and return this form no later than June 18th. Signing of this form confirms your child will attend Credit Recovery Summer School, and you have made arrangements for transportation to and from school.
