Dear Parent/Guardian:

The staff at Tuscola High is pleased that your child is considering taking one or more *advanced* classes next year. For the AP (Advanced Placement) courses, the college-level work is strenuous, but the rewards for making the commitment and seeing it through are great. You may already know that a passing grade on a College Board AP test in high school allows a student to enter college with credit earned ahead of time. Each year Tuscola has a significant number of students who enter college with various amounts of credit earned through AP courses. To compensate for the increased difficulty of the AP and Advanced courses, AP classes are weighted with two extra points awarded in computing a student's Grade Point Average, while *Advanced* courses are awarded one extra point.

Please understand Tuscola's policies concerning all *advanced* courses. Once students have made their final class selections, changes will not be made except in cases of administrative decisions. Thus, both students and parents should be very certain of the commitment they are making. Additionally, students taking AP classes are offered the National Advanced Placement Test for each AP course at a cost of \$87 per test, which a student must take and pass in order to receive college credit. The fee for *each* test will be collected in the fall of next school year on or before *November 18, 2011*.
