All new students must complete an HCC application **prior** to this permission form. The **online application** is available at <u>www.haywood.edu</u>, under Current or Prospective Students, Forms. Students enrolling in this program must present the signed and approved Dual enrollment form <u>in person</u>, in <u>Student Development Services</u> on the HCC Campus. The Dual Enrollment program enables qualified students who are enrolled in NC high schools, NC private schools, or registered NC home schools to take courses at HCC for college credit or personal enrichment. **HCC awards college credit only**. Whether or not high school credit is awarded is up to the receiving high school. Students in the program must have the approval of their principal or other designated school official. Dual enrollment students are considered HCC students. While exempt from payment of tuition and fees for college level classes, students must pay for continuing education and self-supporting classes. Note: some classes carry a mandatory insurance charge that cannot be waived. Dual enrollment students must pay for textbooks, and other supplies required of all HCC students. Completed courses are reflected on official HCC transcripts. A new approval form must be submitted for each registration period or drop/add. Dual enrollment students will be registered for chosen courses after traditional students have had the opportunity to register during posted registration days. They may not register during the pre-registration period. HCC will accept Dual Enrollment approval forms prior to registration but students are not guaranteed placement into chosen classes. At the end of the posted registration process, students will be registered for classes according to the date on which they submitted their approval form. The earliest received forms will be registered first and registration will continue until students are registered or courses become full. Dual Enrollment students are strongly encouraged to apply online at <u>www.haywood.edu</u> prior to the registration per
