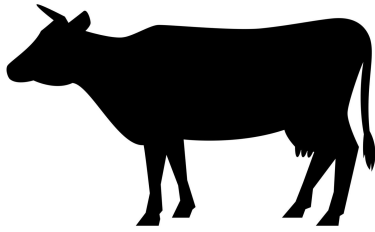
## Grading
