## **Parent Portal Use Agreement Application For Access**

The Haywood County School System is excited to be utilizing one of the features available through the district's Students Information System called the PowerSchool Parent Portal. The portal provides parents with the privilege of accessing their children's records through a secure internet connection. You must agree to the following terms and conditions prior to accessing the PowerSchool Parent Portal.

Access to your child's grades and attendance is provided through PowerSchool as another form of communication with the goal of supporting your child's education. Please read the following guidelines carefully and fill in the required information attached to access the Parent Portal. Participating parents/guardians will be expected to act in a responsible, ethical, and legal manner, as well as to abide by and support the following guidelines:

- 1). Keep your username and password confidential. Best practice is not to share your login information with your child as there is parent-specific information that should not be available to students.
- 2). It is your responsibility to determine which parents or guardians are able to access records. By logging into the PowerSchool Parent Portal, you acknowledge that you are duly authorized to view the site. Users will not attempt to gain unauthorized access to the district system or go beyond their authorized access. This includes attempting to login through another person's account or access another person's files. Inappropriate use will result in cancellations of a user's privilege.
- 3). Parents who are identified as a security risk to the Parent Portal will be denied access to the Parent Portal.
- 4). Grade concerns should first be addressed in a conversation with your child. If your concerns are still unresolved, follow up with your child's teacher by phone or email.
- 5). The Haywood County School System reserves the right to monitor, inspect, copy, review and store at any time, and without prior notice, any and all usage of the PowerSchool Parent Portal and any and all information transmitted or received in connection with such usage. All such information files shall be and remain the property of the school district.
- 6. I release Haywood County Schools from any and all liability for damages arising out of unauthorized access to this account.
